Student Records Welcomes New Director

The Office of Student Records is under new leadership with the appointment of Kimberly Page as Director of Student Records. Kim comes to UMaine from the University of Connecticut where she has worked since 1980, most recently as Associate Registrar for systems and degree audit in the Office of the Registrar. Her academic career started in the College of Liberal Arts and Sciences where, in 1999, she served as acting Assistant Dean before becoming a systems administrator in the Office of the Registrar. Kim has a master's degree in educational leadership and a bachelor's degree in human development from the University of Connecticut.

Viewing Honors and Award Information in MaineStreet

The Student Services Center in MaineStreet provides the ability for faculty and staff to view academic data for students from one general location. As students move through their academic careers, they earn a variety of academic achievements which display on the academic transcript such as Dean's List, Presidential Scholar and induction to Honor Societies. These achievements may be



seen in MaineStreet by navigating to the Student Services Center and scrolling down to the "Personal Information" section on the Student Center Tab. Those users with access to this data will have a link labeled "Honors and Awards." Selecting this link will display a page providing the Academic Honors and Awards mentioned above along with the term and date on which the awards were granted.

Faculty and Advisor E-mail Addresses

aineStreet offers the ability for faculty and advisors to easily communicate via e-mail with their students. The Advising Center as well as the Class Roster allow the user to create an e-mail message and send it to either a selected set of students or all students in the associated listing.

This type of notification process is available throughout many areas of MaineStreet and utilizes the UMS e-mail account ("@maine.edu") as the receiving e-mail address. All University of Maine System employees and students have a UMS e-mail account to which communications

from UMS and MaineStreet are sent. For this reason, it is vital that anyone not using their UMS e-mail account on a regular basis, make an effort to forward the messages received at this account to another regularly used e-mail address.



This is a simple process that takes only a few minutes to accomplish by following <u>the instructions found on the</u> <u>OSR website</u>. All UMaine students are also strongly encouraged to change the forward settings on their UMS e-mail account.

Faculty who utilize electronic teaching tools such as electronic course management systems may wish to share students' e-mail addresses in a class with others in the same class. A 2009 FERPA amendment clarified that a student cannot be "anonymous" in class even in a distance learning setting. While grades and other personally identifiable information that relate to the student's progress in the class cannot be disclosed, it is appropriate that contact information be shared if the class includes online discussions.
