Last Date of Attendance Information

t this time last year, this newsletter provided information regarding the collection of the Last Date of Attendance information. Federal regulations require that the Office of Student Financial Aid determine the last date of attendance for all students who discontinue class attendance. If a student does not officially withdraw, the latest date of a given academically-related activity is the date that is determined to be the student's withdrawal date. Charges and financial aid will be recalculated based on this date.

A new process was introduced last spring providing a means to collect the Last Date of Attendance information in MaineStreet at the time of grading. Another modification has recently been completed to allow appropriate staff to view this information in the Academics tab within the Student Services Center. When viewing the class data for a student for a given term in the "Classes" section, new fields have been added to the display grid including the *Never Attended* flag and *Last Date of Attendance*. Previous to this enhancement, access to this information required navigating to another page in MaineStreet.

Preferred Name in Advisee List

dvisors will notice a change in the display of the names of their advisees in their MaineStreet Advisor Center. The name that a student has designated as their Preferred Name now displays in the Advisee List followed by their Primary Name in parentheses. This change is the same as the one applied several months ago to the Class Roster and Grade Roster. Instructors and advisors can use this information to address their students by the name they prefer as some students object to being addressed by their Primary Name or having it known to others.

Grades By Text Message

tudents at the University of Maine System campuses may now register to receive notifications of posted grades via SMS Text Messages. Registration for the service is available in MaineStreet in the Student Center. To begin the registration process, students select the "Text Messaging Service" link located in the bottom right corner of their Student Center. UMS Academic Program Search

he University of Maine System has created a search tool to assist prospective students with identifying the academic programs offered throughout the System. Searches for programs can be performed using multiple types of criteria including institution, subject, and degree level. A keyword search is also available. Spring Grading Information Grades submission deadline: May 16, 2014.

Incomplete Grade Reporting: When faculty assign an incomplete grade for undergraduate students in the MaineStreet Grade Roster, MaineStreet will display a page where information related to the incomplete grade is to be entered. This electronic process replaces the paper Incomplete Grade Reporting form. The information requested on this page includes the work the student needs to complete, the deadline by which the work needs to be completed, and the grade that the student has earned to that point. Once the incomplete grade is posted, the Incomplete Contract information can be viewed in the Student Center by the student as well as staff in the Student Services Center.



Legitimate Educational Interest

In order for a school official at the institution to have access to student education records, the official must have a **legitimate educational interest** in the records being accessed. **Legitimate education interest** means that the official has a need to access the student education records for the purpose of performing an appropriate educational, research or administrative function for the institution. It is not a legitimate educational interest for faculty to review a student's previous academic history in other classes prior to assigning a final grade.
